Reports

Treasurer

Boys Youth

Remains vacant Need filled – will be a two-year term. Dave and Jody are working on a schedule in the meantime. Clubs will be responsible for any changes once the schedule is released.

Girls Umpires

Training and recruiting will begin after the January 31 meeting. There are seven returning umpires. Training will be in a few different formats: classroom clinic, at a school, and the Jamboree as field training. Umpires will meet in February about rules changes. WLF announce last week that Wisconsin officials are not recognized in the State. They have been invited to send reps to become formally recognized.

Boys Youth Officials

Training is scheduled for 2/28 and 3/6; field training will be at the Jamboree. Foresee possible challenges for the MALA cup.

Boys High School Officials

There are very few new referees. Please refer adults to work with youth games for one year, then move to high school. Varsity games will have 3-man crews with no more than one game of a 2-man crew. The Jamboree is 3/19 and 3/20. There is new management for the concessions at Woodside.

New Business

<u>Dick's Sporting Goods/Abby</u>: Lacrosse shopping days 2/27 and 2/28 – shop all weekend for 20% discount storewide. There is a second date in April. Currently working to get vendor support (name brand vendors) for one store or change stores for both dates. Looking to get STX for example. If items are not available in store, can order to ship to your home. Would be beneficial to have someone from MALA there to greet members. Dick's has uniform services as well. There will be additional 20% coupons available.

<u>Increasing visible presence</u>: MALA Board shirts will be ordered to promote a physical presence at games and events. Dave will send an e-mail requesting sizes.

<u>Girls National tournament</u>: This has been approved (had to be part of Illinois group; not supposed to know who is who). Wisconsin is getting their own team. WLF has been working with coaches. Freshmen to Juniors will be able to tryout. There will be 24 players and alternates.

No pre-nomination for All-American. Unsure at this point who can nominate. There will be 1 All-American and 1 Academic per six teams. Academic will be online -3.7 GPA needed for Juniors and Seniors only to qualify and they must be a major contributor. MALA will propose to WLF to cement chair people. Indy and Steve will forward a coach list to WLF.

<u>DeForest HS Girls grant application</u>: The board discussed the DeForest grant application requesting \$5,620 to launch their Varsity Girls. They expect about 23 players and plan to mix up their schedule to include from JV-level scrimmages for the new players. MOTION made by Steve to award \$1,000, second by Indy; all ayes from board members present. MOTION PASSED.
