Upcoming target dates are Sunday, May 19, 2019 for the 2020 schedule and finalized by July 1 2019. Generally the schedules flip every other year and a complete re-do the schedule happens for the 3rd year of play.

Scholarships for the players are award at the club level and not the Association level.

U8 and U6 were sent the official rules and we requested to communicate to their clubs, this level is for teaching and learning purposes.

Games times are: U8 and U6 are 51 minutes and fields reserved for 90 minutes. This does cause field dead time and is being looked at to alleviate the glitch. We want to be able to maximize the officials time vs having them wait around for long periods of time.
