A. General updates

Web platform update: explored which was Blue Sombrero was bought by Sports Stack, Team Snap and Sports Engine. Sports Engine is the best option but expensive set up fee and then \$750 annual fee. US Lacrosse is developing their own platform and will be free to member

organizations, however it's not ready yet. Recommendation is to wait another year to see if US Lacrosse's platform will be ready. Wade Rewey indicated that only Sports Engine has a fully developed platform. League Athletics is now owned by Sports Engine and will begin to charge a \$750 annual fee.
